*By accepting the terms of this agreement and in consideration of the acceptance of this registration for display of the Kids As Peacemakers mural in the name of Kids As Peacemakers Inc. (formerly The Dove Campaign of Greater Newburyport , MA, hereinafter referred to as "Kids As Peacemakers") I do for myself, my heirs, my assigns, and personal representatives and my Organization (or, if applicable, for my child or ward, and his or her heirs, assigns, and personal representatives) (i) hereby waive release and forever discharge any and all claims or rights, which presently exist or may hereafter accrue against Kids As Peacemakers, the benefiting charitable organization, all sponsors, representatives (including event volunteers), and involved municipalities or other organizations and boards, trustees, directors, officers, employees of any of them from any and all claims or liabilities of any kind arising from the displaying of the {Kids As Peacemakers mural(s)} participating in the Kids As Peacemakers even though that liability may arise out of negligence, recklessness, or carelessness on the part of the persons or entities named in this waiver. (ii) I agree to indemnify and hold harmless Kids As Peacemakers from any and all claims made by any and all parties regardless of merit, from any and all injuries suffered as a result of the displaying of the Kids As Peacemakers mural regardless if the displaying was proper or improper. (iii) I will ensure and be solely responsible, that the displaying of the Kids As Peacemakers mural will comply with any and all local, state, and federal building codes and any and all other codes, laws, and regulations from whatever governmental agency or organization that regulate the displaying of Kids As Peacemakers murals. I further agree, that, if in breach of this agreement, I institute any judicial proceedings against any of the persons listed in this agreement in connection with the Kids As Peacemakers, I shall bring them in the Newburyport, MA Court. I consent to personal jurisdiction in that Court. I further agree that, if in breach of this agreement, I institute any such proceedings, I am responsible for all costs and attorney fees of any person or entity against whom I institute such proceedings.
